

	Illness from disease /virus	М	Yes	<ul> <li>Contractors are advised to check the destination countries vaccination requirements and recommendations on the NHS fit for travel website, and review health advice on destination countries through the foreign office (FCO) website.</li> <li>Anti-malarials are advised by the Client in advance of travel when applicable and should be taken</li> <li>Good hygiene practises are communicated to contractors prior to travel via the Client's Country Brief</li> <li>Contractors must have an in date medical prior to overseas travel. All pre-existing medical conditions must be declared (failure to do so may affect our repatriation insurances)</li> </ul>		
	Injury due to Vehicle accident	М	Yes	Our contractors are not usually asked to drive client company vehicles or hire cars, however they are often transported in a Client vehicle from the airport to the wellsite.  - Only travel with reputable transport companies (client approved)  - Always wear a seat belt when provided  - If there is a need to hire a car for any reason whilst abroad, be familiar with destination country travel laws and customs prior to travel. See Client Country Brief if applicable  - Always take out the highest levels of insurance when hiring a vehicle and only drive if it is unavoidable. 			<ul> <li>Ensure your UK drivers licence is valid and be aware that some countries require an International Driving Permit before you can legally drive a vehicle there</li> <li>Avoid travelling for long periods of time to avoid driver fatigue. Regular rest breaks should be taken (e.g. After driving for 2 hours it is recommended that a 15 minute rest break be taken)</li> <li>Ensure any vehicles driven are fit for purpose and well maintained</li> </ul>		
Contaminated drinking water / food	M	Yes	<ul> <li>If there are any doubts about the drinking water then it should be sterilised (or boiled) prior to use.</li> <li>Avoid having ice in drinks</li> <li>When drinking out go for bottled / boiled drinks.</li> <li>Avoid food which may have been 'kept warm' for a prolonged period</li> <li>Avoid uncooked food unless you can peel / shell it yourself</li> <li>Avoid or boil unpasteurised milk</li> <li>Eat freshly cooked food which has been thoroughly cooked (piping hot)</li> </ul>	L

Communication (break down of)	М	Yes	<ul> <li>Contractors should always travel with a mobile telephone so that they are able to summon help. Ensure your mobile is unlocked for international travel</li> <li>Next of Kin details must be on file prior to travel</li> <li>Wellwise and client contact numbers should be at hand at all times when travelling</li> <li>Always carry telephone numbers for the British Embassy/Consulate in the destination country (these can be found on Foreign Office website)</li> </ul>	L	
Stress	L	Yes	<ul> <li>Always be prepared for your required travel to reduce unforeseeable circumstances and subsequently stress</li> <li>Always allow enough travel time to avoid missing flights /check in times</li> <li>Ensure you have all of your required travel documents in place (passport, tickets, visa etc.)</li> </ul>	L
