If you need to carry medication with you, it should not be over 50 ml and in liquid form as you will not be permitted to carry it onboard. Liquid medication should be under 50 ml and you will be asked to taste the liquid in order verify that it is genuine medication. There is no restriction to powder or tablet medication.

The usual restrictions still apply for other dangerous items, such as knives, scissors, flammable liquids, etc.

NOT PERMITTED

Drinks

Any drinks in cans, bottles, plastic containers, cardboard cartons, etc.

Cosmetics and toiletries

All consumable cosmetics and toiletries (solids and liquids) eq:

- Soaps
- Any aerosol item
- Creams
- Deodorants
- Lip Balm
- Sun tanning products
- Toothpaste
- Talcum Powder
- Bottles of contact
- er lens solution

Food

• Any liquid based food products in packets, tubes, plastic or tin containers.

Writing Implements

Spare cartridges for fountain pens

Smoking materials

Cigarette Lighters Non safety matches

Security ID cards for Australia (MSIC)

New Maritime Transport and Offshore Facilities Security Regulations which cover activities at all ports, ships and offshore oil and gas facilities have recently come into force in Australia.

Part of these new regulations includes the introduction of the Marine Security Identification Card (MSIC) which is required for all personnel who require access to or work in maritime security zones of our ports, ships and offshore facilities. The MSIC is a nationally recognised security identification card which confirms that the cardholder has met the minimum security requirements to access or work unmonitored in a Maritime Security Zone (MSZ).




MSIC regulations will come into effect on 1 January 2007 and from this date all personnel entering any MSZ's will be required to have an MSIC. The MSIC is not facility specific therefore you do not require a separate card for each Operator you work for.

To enable the MSIC to be applied for the traveller will need to have a Business 457 type visa. Wellwise Group is currently applying for a sponsorship arrangement to enable Business Visas to be arranged, as soon as this is set up they will be processing applications for those who wish to return to Australia.

The MSIC application process involves a criminal background check by the Australian Federal Police and the Australian Security Intelligence Organisation. All applicants will need to prove that they have a right to work in Australia, ie producing a valid visa with work rights. A verifiable reference will be provided by Wellwise Group.

There are between 150,000 and 250,000 people in Australia who will need these cards between now and January so there will be a huge wait for background checks. After issue an MSIC is valid for 5 years.
